Minimum Qualification for nominee (as on last date)	An academican /scholar of outstanding track record in the designated <u>areas of studies for the Chair*</u> with minimum eligibility criteria for the post of Professor as prescribed by UGC Regulations 2018. <i>*Areas of studies for the Chair: Tribal Studies, Anthropology, Sociology, Social Work, History, Culture & Freedom Movements.</i>
4.	Age	55 - 70 years
5.	Pay Scale/ Consolidated pay	Academic level-14 (Professor) with rationalized entry pay of Rs. 144200/- (in case a working person is appointed to the Chair) and 1.00 lakh (Consolidated) for a retired Professor.
6.	Mode of Engagement and Tenure	On Contract basis, initially for a period of one year or till further order, whichever is earlier. It may be further extendable (not more than 5 years) as per requirement/ discretion of the Competent Authority.
7.	Selection process	The duly constituted Selection Committee shall scrutinize the nominations received and recommend suitable candidate to be appointed for the position.

The Vice-Chancellor of any University can nominate eligible and willing academican/scholar by sending their CV/Biodata alongwith supporting documents/ certificates regarding qualifications, experience, achievements etc. to the **email-recruitment@igntu.ac.in** on or before **15/09/2023**. Email received after due date or incomplete in any respect shall not be entertained without any notice.

Term & Conditions:

- Engagement of Chair Professor is subject to approval and sanction of fund by UGC.
- During the engagement process or after engagement of the above posts if suppression of facts are detected, the application will be rejected and the applicant will be liable for action as applicable under the provisions of rules and laws in force.
- Any amendment to the scheme will be applicable and bound to stakeholder as per order of the Competent Authority. Scheme is co-terminus with chair.
- Initially the engagement for the said post will be for one year or til further order, whichever is earlier. It may be further extendable (not more than 5 years) as per requirement/ discretion of the Competent Authority.
- In case of any ambiguity pertaining to term and conditions of the Engagement, the decision of the Competent Authority shall be final.
