**Instructions to attend Walk-in-interview:**

Interested candidates may attend walk-in-interview on given schedule and venue with bio-data in the prescribed format attached alongwith original and self-attested copies of documents as mentioned in para-7 below. Candidates are also advised to read this notice carefully before attend the walk-in-interview.

**GENERAL CONDITIONS**

1. The posts are purely on temporary / contract basis and initially for a period of six months. The selected candidates shall have no claim for regular appointments.
2. The date for determining the eligibility of all candidates in every respect shall be the date of walk-in-interview. In other words, no candidate shall be allowed for walk-in-interview if he/she does not possess the minimum qualification and experience etc. as on the date of the walk-in-interview for a particular post.
3. Candidate who is already in service should submit his/her application through proper channel.
4. It is the responsibility of the candidate to assess his own eligibility for the post for which he/she is applying in accordance with the prescribed qualification, experience etc. and submit his/her application duly filled-in along with desired information, documents and other supporting materials as per the advertisement. Suppression of factual information, supply of fake documents, providing false or misleading information or any other undesirable action by the candidate shall lead to cancellation of his candidature. In case, it is detected at any point of time in future even after engagement that the candidate was not eligible as per the prescribed qualification, experience etc. which could not be detected at the time of engagement due to whatever circumstances, his/her engagement shall be liable to termination forthwith as per this clause and also based on his undertaking.
5. Remuneration shall be paid a monthly consolidated amount as mentioned.
6. Maximum age limit is 40 years as on the date of walk-in-interview. Relaxation to SC/ST/OBC/PWD candidates will be given as per rules.
7. The candidate who fulfills the requirements may attend the walk-in interview as per the schedule given below along with original documents and two sets of self-attested photocopies of certificates and qualifications along with experience, mark-sheet, birth certificates, caste certificates, two passport size photographs etc. at the venue on scheduled date and time. Applicants appearing for the interview with incomplete documents will not be entertained.
8. No TA/DA will be paid to the candidates to attend walk-in-interview.
9. Candidates are advised to visit the University website regularly for updates related to recruitment notifications.

10. The University reserves the right to fill or not to fill up the posts advertised for walk-in-interview any reasons whatsoever.
11. Merely appearing in walk-in-interview does not make candidate entitled for the selection.
12. University may reserve right to terminate engagement at any time without any prior notice.

The University reserves the right to withdraw the advertisement either partly or wholly at any time without assigning any reason to this effect.

The University reserves the right to increase or decrease the vacancies according to the circumstances.
